There will be a 3% raise for all.

Supervisor Stocklosa advised that he had met with Kathy Kupiec of Adirondack Financial, with regards to the Town's Health Insurance Policy. He advised that the employee health insurance will increase by 4.91% +/- and that the Town will have to further discuss the retiree insurance, as that may possibly increase 28% +/-.

Therefore, be it resolved that the Town Board of the Town of Boonville supports a grant application in the maximum amount that can be obtained to cover costs associated with metal shelving, entrance floor mats and executive chairs.
