Mr. Bouchard advised the Board that he has spoken with County Executive, Anthony Picente and County Attorney, Andrew Dean and that they are willing to cooperate and working on getting a master plan together.

ZEO/CEO, Ken Doolittle spoke to the Board regarding the Junk Law. Mr. Doolittle advised that he has sent out complaint letters the homeowners along with violation letters by certified mail and that some people have started to comply, and others have not which will need to be ticketed.

Supervisor Stocklosa advised the Board that he has received a letter from Oneida County stating that the County revised their tax figures which show's \$176.67 less than what the Town was told, which comes after the Town's 2025 budget was submitted to the County.
